## **Terms and Conditions of Sale**

### **Credit Terms**

All payments are net 30 days. Buyer agrees to pay a carrying charge of 1.5% per month on all overdue accounts, amounting to an annual rate of 18%. Buyer also agrees to pay legal fees and costs incurred by Magic Growers in collection of this indebtedness.

### **Adjustments**

Errors involving storage, variance in grade, type, variety, species and damage in route must be reported in writing to Magic Growers within 48 hours after receipt of shipment in order to have a claim considered.

### **Holding Policy**

Due to the perishability of our product, plants will be held no longer than 15 days from the date ordered. If it becomes necessary to hold material beyond 15 days, then full prepayment will be required and a monthly maintenance fee will be charged on any order held more than 30 days.

### **Canceled Orders**

Customers will be charged a restocking fee amounting to 20%, of the value of any order canceled less than one full day prior to the scheduled day of delivery.

### **Preliminary Lien Notice and Material Release**

We will request all information as to developer (owner), general contractor and lender on all job sites where we deliver on "credit" .

### **Delivery and Pickup Policy**

Delivery by our trucks within our regular delivery area requires a minimum order of \$300.00 dollars. A delivery charge will be added to all deliveries, in southern California, using our truck. We try to accommodate all will-call customers (wholesale only) however, we will appreciate your giving us 24 hour notice on larger orders. Will-call service is available Monday through Friday between the hours of 7:30AM and 4:30 PM. Saturday pickups can be arranged only on an appointment basis. Shipping to customers outside of California is worked out on an individual basis with a frequency as needed.

### **Cash and Credit Purchases**

All orders delivered prior to approval of the customer's credit are C.O.D.. A credit application is available on request. Verification of credit information and references usually takes two weeks to process after receipt of your application.

### **Discounts**

\*\*Volume discounts apply to orders delivered to our customers as follows: orders including a;

Single order of 25 or more "1 gallons" of the same variety receive a discount of 5%

Single order of 10 or more "2,3,or 5 gallons" of the same variety receive a discount of 5% All Will Call orders of more than \$100 receive a discount of 5%

\*\*Discounts are not cumulative, only the single largest discount will apply to anyone sale.

### **Warranty**

Magic Growers gives no warranty, express or implied, as to the variety, productivity or quality of any nursery stock it sells. Magic Growers will exercise care to have all plants true to name. Nevertheless, it is understood that should any plant prove otherwise, we shall not be liable for any sum greater than that paid for such plants as may prove untrue. If the purchaser does not accept the goods on these terms, they are to be returned at once. We accept all orders on condition that same shall be void should any injury befall our nursery stock from fire, floods, drought, war, strikes, embargoes or any other cause which could not be prevented and over which we have no control.
